A local company Earth Warriors Composting offers a paid pick-up service to take compostables away and process it. The service is charged by weight with an estimate of \$100 - \$150 monthly, for the Courtenay NISU Eats. Though the Climate and Sustainability Committee at the college has discussed engaging with a compost provider for all campuses, this has yet to come to fruition. Therefore;

Therefore, Director Collett proposes that NISU collaborates with the Comox Valley Regional District and North Island College to provide a Swim -Safe program for international students to receive swim lessons and learn the necessary skills to assess risks around different swim environments. Furthermore, the program can support six participants for a total cost of \$321.60 per course. The Office of Global Engagement is prepared to contribute approximately 50% of this cost, leaving the cost for each participant at approximately \$27. Whereas, this program is an opportunity to continue NISU's work in building community relationships and providing valuable services.
